No. 482752-HIII(2)-2025/14792.—In exercise of the powers conferred by the Govt. of India, Ministry of Home Affairs, Notification No.2506(E) dated 28.06.2024 and in order to implement Sections 105, 173, 176, 180, 185 and 497 of the Bharatiya Nagarik Suraksha Sanhita, 2023 read with Section 530 of the Bharatiya Nagarik Suraksha Sanhita, 2023 (46 of 2023) and Section 63 of the Bharatiya Sakshya Adhiniyam, 2023 (47 of 2023) and for electronic management of evidence (eSakshya) during investigation in criminal proceedings and trial, the Administrator, UT Chandigarh in consultation with Hon'ble High Court of Punjab & Haryana, hereby frames the following rules, namely :-

1. Short title and commencement.-

- a) These rules may be called the Union Territory Chandigarh (eSakshya) Management Rules, 2025.
- b) They shall come into force from the date of their publication in the Official Gazette.

2. Definitions.

(1) In these rules, unless the context otherwise requires,-

- a) "CCTNS" means Crime and Criminals Tracking Network and Systems, a system software used by the Police for the collection of data and execution of instructions;
- b) "CIS" means Case Information System, used by the District Judiciary and High Courts for the collection of data and execution of instructions;
- c) "eSign" means authentication of any electronic record by a subscriber or court, by means of the electronic technique specified in the Second Schedule of the Information Technology Act, 2000 (21 of 2000) and includes digital signature. Also, when a process or report generated in electronic form is authenticated by means of electronic signature, it shall be deemed to be authenticated by signature of the person who affixed the electronic signature;

- d) "Hash Value" refers to a unique digital fingerprint at an electronic record, used to verify its authenticity and integrity, ensuring that the data presented in Court matches the original;
- e) "High Court" means the High Court of Punjab and Haryana, Chandigarh;
- f) "Immutable storage" means and include Digi-locker and any other storage method where once data is written, it cannot be modified, deleted, or overwritten for a set or indefinite period, ensuring data integrity and compliance.
- g) "ICJS" shall mean Inter-operable Criminal Justice System, a software presently in operation for transfer of information among various pillars of criminal justice system, which includes investigating agencies, courts, correctional homes, forensic laboratories, prosecution and any other stakeholder as notified by the central government;
- h) "Investigating Officer" means any police officer or any other person authorized by a competent authority or empowered to undertake investigation for any offence;
- i) "Sakshya" means any evidence collected/ recorded as a document through eSakshya Mobile Application of the National Crime Records Bureau, Ministry of Home Affairs, Government of India or any other application developed and maintained for this purpose by the State Government or the National Crime Records Bureau, Ministry of Home Affairs, Government of India from time to time. Sakshya consists of audio-video recording(s), photograph(s), audio-video recording(s), and photograph(s) of the investigating/ recording officer or a person whose statement is recorded during investigation. All evidence recorded through eSakshya Mobile Application shall generate a secure packet of the event (hereinafter referred to as 'eSakshya Packet') with a unique ID called SID, a unique 16 digit ID (SID) with opening, closing time stamp and geo-location. Each SID and its contents will have unique hash value to ensure integrity. Sakshya will be stored in immutable storage;
- j) "Sanhita" means the Bharatiya Nagarik Suraksha Sanhita, 2023 (46 of 2023).

(3) Words and expressions used, but not defined in these rules shall have the same meaning as assigned to them in the Bharatiya Nagarik Suraksha Sanhita, 2023 (46 of 2023); the Bharatiya Nyaya Sanhita, 2023 (45 of 2023); the Bharatiya Sakshya Adhiniyam, 2023 (47 of 2023) and the Information Technology Act, 2000 (21 of 2000).

(4) During trial, appeal and other criminal judicial proceedings, the e-Sakshya packet will be accessible to the concerned Court through the CIS application/Sakshya portal on ICJS.

(5) Every Investigating Officer shall record all audio-video recording (s) and photograph(s) evidence as required under sections 105, 173, 176, 180, 185 and 497 of the Sanhita through the eSakshya Mobile Application of the National Crime Records Bureau, Ministry of Home Affairs, Government of India or any other application developed and maintained for this purpose by the

State Government or the National Crime Records Bureau, Ministry of Home Affairs, Government of India from time to time.

- (6) Investigating Officer shall generate a certificate under section 63 (4) (c) Part A of the Bharatiya Sakshya Adhiniyam, 2023 (47 of 2023) through the eSakshya Mobile Application of the National Crime Records Bureau, Ministry of Home Affairs, Government of India or any other application developed and maintained for this purpose by the State Government or the National Crime Records Bureau, Ministry of Home Affairs, Government of India from time to time. All Certificates shall be eSigned by the investigating officer. The certificate shall include the hash value of the electronic record and the specific algorithm used to generate that hash value, as prescribed in the Schedule of the Bharatiya Sakshya Adhiniyam, 2023.
- (7) Investigating Officer shall link SID with the concerned FIR number/ GD number generated through CCTNS or any other application developed and maintained for this purpose by the State Government or the National Crime Records Bureau, Ministry of Home Affairs, Government of India from time to time.
- (8) The Sakshya uploaded to immutable storage shall be construed to be forwarded to Magistrate as required under section 105 and 185 of the Sanhita.
- (9) The courts may share Sakshya with accused and the victim (if represented by an advocate) as per the provisions under section 230 of the Sanhita. The e-Sakshya packet will be shared through electronic means (Portal or PEN drive) only upon specific directions of the Court.
- (10) The judicial officer dealing with the case can access the e-Sakshya packet as per the process presently embedded with the CIS, which includes provisions for temporary assignment of cases during leave or transfer of the officer.
- (11) eSakshya packet will be archived after completion of all proceedings in the trial courts. It will be moved to a dedicated archival storage, which can be retrieved within a period of 5 days upon orders from the concerned court.
- (12) Nothing in these rules shall be deemed to limit the power of the Courts to view the Sakshya by the Court.
- (13) These rules shall be in addition to, not in derogation of any other law or rules for time being in force for accepting and managing Sakshya by the Court in terms of the provisions of Bharatiya Sakshya Adhiniyam, 2023 (47 of 2023).

No. MOH/C&D/2025/14013.—Whereas, the draft “The Municipal Corporation Chandigarh Pet and Community Dogs Bye-laws, 2023 was published inviting suggestions/ comments from persons likely to be affected thereby, before the expiry of the 30 days period from the date of publication, in supersession of “The Chandigarh Registration of Pet Dogs Bye-laws, 2010” and its amendments, as approved by the General House of the Municipal Corporation, Chandigarh.

And whereas, copy of the said draft was made available to public on 07.02.2025 as it was uploaded on the official website of Municipal Corporation along with publication in the three leading newspapers.

And whereas, the objections or comments received within the stipulated period were duly considered by the committee constituted for this very purpose.

Now, therefore, in exercise of the powers conferred under subsection (1) of section 401 read with section 325 and section 399 (J)(6) of the Punjab Municipal Corporation Act as extended to the Union Territory Chandigarh by the Punjab Municipal Corporation Law (Extension to Chandigarh) Act, 1994 (Act No. 45 of 1994), the Administrator, Union Territory, Chandigarh is hereby pleased to notify “The Municipal Corporation Chandigarh Pet and Community Dogs Bye-laws, 2025” in supersession of “The Chandigarh Registration of Pet Dogs Bye-laws, 2010” and its amendments, as approved by the General House of the Municipal Corporation, Chandigarh, for the information of the general public and other stakeholders.

Draft Bye-laws

1. Short title:- (i) These Bye-laws may be called "The Municipal Corporation Chandigarh Pet and Community Dogs Bye-laws, 2025."

(ii) These shall come into force on the date of their publication in the Gazette of Chandigarh Administration.

2. Definitions.- In these bye-laws, unless the context otherwise requires-

a) “Act” means the Punjab Municipal Corporation Act 1976 as extended to the Union Territory, Chandigarh by the Punjab Municipal Corporation Law (Extension to Chandigarh) Act, 1994 (Act No. 45 of 1994).

b) “Appellate Authority” means the Commissioner, Municipal Corporation, Chandigarh

or any officer authorized by the Commissioner, Municipal Corporation, Chandigarh to exercise the power of appellate authority.

- c) “ARV” means Anti-Rabies vaccine to save dog(s) from Rabies disease.
- d) “AWBI or Animal Welfare Board of India” means, a statutory body established under the Prevention of Cruelty to Animals Act 1960.
- e) “AWO (Animal Welfare Organization)/Non-Government Organization (NGO)” means any organization or society registered under the Animal Welfare Board of India (AWBI)/the Societies Registration Act, 1860, or any other law for the time being in force, and working for the welfare and protection of animals.
- f) “Care giver/occasional feeder” means those persons who are not registered as a volunteers /dog lovers, occasionally feed and take care of community dogs and owners less dogs.
- g) “Community dog(s)” means any dog(s) that are collectively owned by the community. These may be local Indian dogs or abandoned pedigree dogs that are homeless, living on the street or within gated campus/enclosed compounds.
- h) “Dangerous/aggressive dog(s)” means any dog(s) known to cause harm to humans/other animals or any property of a human being.
- i) “DHPPiL” means vaccine that saves dog(s) from several diseases such as Canine Distemper Virus (CDV), Canine Adenovirus type 1 (ICH), Canine Parvovirus (CPV), Canine Parainfluenza virus (CPi) and Leptospirosis.
- j) “Dog Groomers” means any person who provides his/her services for grooming and bathing pet dog(s).
- k) “Dog Hostels/Crèches” means any establishment/place where dog(s) owners can pay to have their dog(s) looked after while they are away.
- l) “Dog Trainers” means any person qualified from any recognized institution or University with Certification of the same and experienced in training dog(s) for docile behaviour etc.
- m) “Dog Walker” means any person who takes the dog(s) for morning or evening walks.
- n) “Dwelling” means a place of residence where a person or family lives such as house, apartment or other habitable structure and where a pet dog(s) is kept.
- o) “Family” means the people living in the same household as the owner of the pet dog including dog’s primary owner, their spouse, children, sibling, parents or long-term cohabitants i.e., roommates or caretakers.
- p) “Ferocious Dog” means any dog which, without provocation, has attacked bitten or otherwise threaten the safety of a person or another animal in a manner that could cause injury or death.
- q) “Form” means a form appended to these Bye-laws.

- r) "House" means a building or part of building used as residence by individual/separate family or household.
- s) "Household" means all people living together at the same residential address regardless of their relationship who have responsibility for or interact with the dog own.
- t) "Indie" Short of indigenous (mixed) breeds, refers to dogs which are largely a result of cross breeding/inbreeding of native breeds, exhibiting a mix of multiple breeds with some common genetic traits shared with indigenous Indian breeds or other breeds of native Indian pedigree.
- u) "Impounding" means the placement of a dog into a shelter or holding facility due to it being found straying or in violation of these Bye-Laws.
- v) "Leash" means a physical restraint, such as a rope or chain that limits the movement of a pet dog.
- w) "Litter" means disposable waste materials such as plastic packets, empty food containers, wrappers, and bottles that are often left behind at designated dog feeding spots. These items are typically discarded by individuals feeding stray or community dogs. Since dogs may not consume all of the food at once or may leave portions uneaten, the leftover food (not considered as litter) and associated packaging contribute to unsanitary conditions. This accumulation of waste not only creates a public nuisance but also poses health and environmental hazards to both humans and animals. Proper disposal of feeding-related waste and use of eco-friendly containers is strongly encouraged to maintain cleanliness in public spaces.
- x) "Menacing Dog" is a dog that shows threatening behavior, such as growling, longing or chasing people, animals or vehicles without being provoked and has a history of aggression or attacks.
- y) "Mongrel dog" means a mixed breed dog that does not belong to a specific recognized breed and is typically the result of natural (non-selective) breeding between different types of dogs. Unlike pure breed/designer dog (selective breeding), mongrels do not have a known pedigree/lineage.
- z) "Nuisance Dog" is a dog that frequently roams away from its owner's property or damages property not belonging to the owner thus causing disturbance to the neighbors

aa) "Offence" means any act or omission made punishable by any law for the time being.

ab) "Owner" means a person who possess, keeps and harbors the dog(s) and/or has it in his/her custody and one who allows the dog(s) to remain in/about the dwelling occupied by him/her. Where the owner is a minor, the parent, guardian or head of the household is the owner of the dog(s).

ac) "Pet Breeders" means any person who keeps dog(s) for breeding and trading and maintains such activities in accordance with the applicable rules/bye-laws. The

activities of a "Pet Breeder" may include, but are not limited to, the selective breeding of dogs, the sale or exchange of puppies, and related transactions for financial gain.

- ad) "Pet dog(s)" means a male or female dog(s) kept by a person within the area of the Municipal Corporation, Chandigarh.
- ae) "Pet Shop Keeper/Owner" means any person who keeps different types of animals for trading purposes in accordance with the applicable rules/bye-laws.
- af) "Poop Scoop" means a device used to pick up and dispose of a pet dog(s) excrement.
- ag) "Public Place" means any place accessible to/used by the public, including but not limited to parks, roads, sidewalks, and other common areas.
- ah) "Registration Authority" means the Medical Officer of Health, Municipal Corporation Chandigarh or any officer appointed by the Commissioner, Municipal Corporation, Chandigarh for the registration purpose.
- ai) "Rescue" refers to a previously homeless/shelter held all breed (pedigree/indie) dog rehabilitated through adoption after having been abused (neglected) or abandoned by previous family.
- aj) "Running at Large" is a dog found in a public place or on someone else's private property without the consent of the property owner and not restrained or controlled by its owner or handler.
- ak) "SAWB (State Animal Welfare Board) is a governmental body established by a state to promote animal welfare, prevent cruelty, and ensure the well-being of animals within that state.
- al) "Volunteer/Dog Lover" means a registered volunteer/dog lover as per these bye- laws.
- am) The words and expressions not defined in these bye-laws shall have the same meaning as assigned to them in the Punjab Municipal Corporation Act 1976, as extended to the Union Territory, Chandigarh by the Punjab Municipal Corporation Law (Extension to Chandigarh) Act. 1994.

3. Registration and its Renewal and Procedure: The registration of Pet dog(s) (hereinafter mentioned as dog(s)) above the age of four months, kept within the jurisdiction of Municipal Corporation, Chandigarh, shall be compulsory.

- a) The owner shall apply for the registration of dog(s) to the Registration Authority in a Form as per *Schedule-A along with an Undertaking*, as prescribed by the

Commissioner, Municipal Corporation, Chandigarh accompanied by a fee of Rs. 500/- per dog(s), two recent photographs of the dog(s) — one showing the head/face from the front and the other a side view of the standing dog clearly indicating its distinctive features and a copy of vaccination certificate duly attested from a Government or Private Veterinary Practitioner duly registered with the Indian Veterinary Council (IVC) or State Veterinary Council (SVC), as soon as the vaccination is completed to avoid any penalty if dog(s) found unregistered. However, a blind person keeping dog(s) and using solely for his/her guidance shall be exempted from the payment of the registration fee.

- b) On registration, the Registration Authority shall issue a metal token which is to be attached to the collar to be worn by the dog(s), and in case of the loss or destruction of the token, a duplicate token shall be issued to the owner on submission of an application along with a fee of Rs. 500/- per token. The registration once made shall remain valid for a period of Five Years. The registration need to be renewed after every 5 years with the duly attested vaccination record of previous years from a Government or Private Veterinary Practitioner duly registered with the Indian Veterinary Council (IVC) or State Veterinary Council (SVC), along with a fee of Rs. 50/- per dog *as per prescribed form in Schedule-B*. In the case of the death of the dog(s), the owner of the dog(s) shall immediately inform the Registration Authority *as per prescribed form in Schedule-C*.
- c) In case to register the third/fourth dog(s), which must be an Adopted Mongrel/Indie dog, the owner shall apply for the registration to the Registration Authority in a form, as prescribed in **Schedule-A**, along with an undertaking as prescribed by the Commissioner, Municipal Corporation, Chandigarh accompanied by a fee of Rs. 50/- per dog(s), along with two recent photographs of the dog(s) — one showing the head/face from the front and the other a side view of the standing dog clearly indicating its distinctive features and a copy of vaccination certificate duly attested from a Government or Private Veterinary Practitioner duly registered with the Indian Veterinary Council (IVC) or State Veterinary Council (SVC). In addition to this, the owner can get his/her dog(s) sterilized from the Municipal Corporation Chandigarh's Animal Birth Control Programme at no cost. The registration needs to be renewed every 5 years with the vaccination record of previous years along with a fee of Rs.50/- per dog. In the case of the death of the dog(s), the owner

of the dog(s) shall immediately inform the Registration Authority *as per prescribed form in Schedule-C.*

d) A family may keep as many dogs as per the limit prescribed in the table below. If dogs over than the prescribed limit are found to be kept in a house by a family, then the unregistered dog(s) will be impounded, and a penalty shall be imposed on the owner.

4. Obligation of Owner: The owner of registered dog(s) shall be required:

(a) To keep the dog(s) protected by getting it vaccinated with Anti-Rabies and *DHPPiL* or any other vaccination as prescribed from a Government or Private Veterinary Practitioner duly registered with the Indian Veterinary Council (IVC) or State Veterinary Council (SVC). The vaccination certificate shall be furnished on demand during inspection by the Registration Authority or any officer/official of the Municipal Corporation duly

authorized by the Registration Authority or within a period of 10 days from such inspection, by the owner of the dog(s) failing which registration of the dog(s) shall be canceled.

- (b) To keep the dog(s) chained/leashed (not longer than 1.5-2.0 meters) while taking them outside. All ferocious dog(s) shall be duly muzzled and a stick shall be carried by the person accompanying the dog(s) while taking them out. Dog(s) with aggressive behaviour shall be trained through dog trainers registered with Municipal Corporation Chandigarh to avoid any unwanted incidents.
- (c) To ensure that the dog(s) wear a collar affixed with the metal token issued by the Registration Authority, at all the times.
- (d) To compensate the person if a dog bites or causes any other harm to any person or to the property of any person.
- (e) Pet dog(s) Owners must ensure that the dog walker knows how to keep dog(s) in control and has knowledge about these bye-laws. If any violation is committed by a dog walker, penal action as mentioned in these bye-laws shall be taken against the dog(s) owner.
- (f) Pet dog(s) owner must ensure ***Five Freedoms for Animals*** as notified by Animal Welfare Board of India (AWBI), Ministry of Fisheries, Animal Husbandry & Dairying, Government of India which are as under:-
 - i. **Freedom from thirst, hunger, and malnutrition:** Ensuring animals have continuous access to fresh water and a balanced diet to maintain full health and vigor.
 - ii. **Freedom from discomfort and exposure:** Providing animals with appropriate shelter and a comfortable resting area to protect them from environmental conditions.
 - iii. **Freedom from pain, injury, and disease:** Preventing or rapidly diagnosing and treating illnesses and injuries to minimize suffering.
 - iv. **Freedom from fear and distress:** Ensuring conditions and treatment that avoid mental suffering, allowing animals to live without undue stress.
 - v. **Freedom to express normal behavior:** Providing sufficient space, proper facilities, and companionship to allow animals to exhibit natural behaviors

5. Prohibition at certain places: The owner of the dog(s) shall not take the dog(s) to the area of the Sukhna Lake, Rose Garden, Shanti Kunj, Rock Garden, Leisure Valley, Bougainvillea Garden, Chandigarh Botanical Garden Sarangpur and other public places/gardens as notified by the Commissioner, Municipal Corporation, Chandigarh, from time to time.

6. Liability of owner to pay compensation or damages: The owner of the registered dog(s) shall keep the dog(s) under his/her control at all times so that they do not intimidate, annoy, hurt, or bite any person. The Municipal Corporation shall not be held responsible for any loss, damage or injury caused by a registered dog(s) to any person or their property, and the sole liability to compensate the victim, if required, shall remain with the owner of the registered dog(s). The dog(s) shall be impounded for observation of behavior and penalty shall be imposed on the owner.

7. Prohibition against breeding for Commercial or Trading purposes: The breeding of dog(s) for commercial purposes and trading of dog(s) within the area of Municipal Corporation, Chandigarh shall not be permitted except for registered pet breeders and registered pet shop keepers/owners in accordance with the applicable rules/bye-laws. In case it is found that dog(s) are being kept for breeding or trading/commercial purposes by any person or unregistered pet breeder/pet shop owner, the Registration Authority shall impound such dog(s) besides imposing the fine as per these bye-laws.

8. Prohibition against Open Defecation in Public Places: No person shall permit their pet dog(s) to defecate in any public place, including but not limited to residential areas, green belts, parks, streets, roads, road berms, and other common areas, except within their own premises. In the event that the dog(s) defecates in a public space, *the owner/walker shall scoop up the excrement of the dog(s) and place it in a “poop bag” and dispose of the waste via proper disposal method/equipment. In case of failure to do so, a penalty will be imposed over the owner.* The owner of the dog(s) shall take his/her dog(s) to defecate in isolated areas not frequently visited by the residents and other members of the public. No owner shall allow the dog(s) to defecate near the residences of other persons, causing annoyance to them.

All pet owners or persons keeping any dog(s) shall maintain the premises in which the dog(s) is housed in a clean and sanitary condition at all times, so as to prevent any health hazard, nuisance, or foul odour that may cause discomfort or offence to neighbors or persons passing by.

9. Compliance with Statutory Provisions of Other Laws: The owner of the registered dog(s), pet shop keepers/owners, pet breeders, and owners of dog(s) Hostel/crèches shall ensure proper space, accommodation, food and medical treatment for the dog(s)/animals/pets as per the applicable guidelines issued under the Prevention of Cruelty to Animals, Act, 1960 or any other applicable law.

10. Maintain the Proper Register: The Registration Authority or an officer/official authorized by it shall keep the details of all the seized dog(s) duly entered in a register with a brief description of the dog(s), date of seizure/impound, reasons of seizure/impound and the manner in which it is dealt with shall be recorded.

11. Provision regarding Burial and Cremation: The dog(s), after its death, shall not be thrown in the open or in the garbage bins of the Municipal Corporation, Chandigarh. In case of non-compliance with the same, a penalty shall be imposed as per the Schedule VIII. Dead dog(s) shall be buried at a crematorium or individually owned places via Deep Burial Method, up to a depth of at least 3 ft., and covered with lime and salt in a hygienic manner or through Incinerator.

12. Registration of Volunteers/dog lovers/NGOs: Volunteers/dog lovers/NGOs shall register themselves with the Municipal Corporation Chandigarh by submitting the details as per **Schedule-I.** Only Volunteers/dog lovers/NGOs registered with the Municipal Corporation Chandigarh or AWBI will be collaborated in any programs/services/assistance required for the well-being of Community dogs. Unregistered persons/organizations will not be entertained. Any breach of the norms set forth by AWBI or under these byelaws, and any decisions related thereto, shall be subject to the prescribed consequences and enforcement.

13. Registration of Pet breeders: Pet breeders shall register themselves with the Municipal Corporation Chandigarh by submitting the details as per **Schedule-II**. The said business shall be carried out in accordance with the applicable rules/bye-laws. Pet Breeders operating within the municipal limits of Chandigarh shall adhere to the provisions outlined in the Prevention of Cruelty to Animals (Dog Breeding and Marketing) Rules, 2017, as amended from time to time.

14. Registration of Pet Shop Keeper/Owner: Pet Shop Keeper/Owner shall register themselves with the Municipal Corporation Chandigarh by submitting the details as per **Schedule-III**. The said business shall be carried out in accordance with the applicable rules/bye-laws. Pet shops operating within the municipal limits of Chandigarh shall adhere to the provisions outlined in the Prevention of Cruelty to Animals (Pet Shop) Rules, 2018, as amended from time to time.

15. Registration of Dog Trainers: Dog Trainers shall register themselves with the Municipal Corporation Chandigarh by submitting the details as per **Schedule-IV**. The said business shall be carried out in accordance with the applicable rules/bye-laws.

16. Registration of Dog Hostels/Crèches: The owners of Dog hostels/crèches shall register themselves with Municipal Corporation Chandigarh by submitting the details as per **Schedule-V**. The said business shall be carried out in accordance with the applicable rules/bye-laws.

17. Registration of Dog Groomers: Dog Groomers shall register themselves with the Municipal Corporation, Chandigarh by submitting the details as per **Schedule-VI**. The said business shall be carried out in accordance with the applicable rules/bye-laws.

18. Designated Feeding Spots for Community Dogs:

(1) The Municipal Corporation Chandigarh through its authorized official(s) in coordination with concerned stakeholders shall designate appropriate places and timings for the feeding of community dogs within their respective localities, in accordance with Section 20, Sub-section (1) (i) and (ii) of the Animal Birth Control Rules, 2023.

The reserved feeding areas should be:

- Away from play areas of children, entry and exit points and stairways
- In the least-used areas by children and elderly
- Away from high-traffic areas, playing areas or walking routes for dogs

The feeding spots identified and approved by the authorized officials of the Municipal Corporation, Chandigarh in coordination with concerned stakeholders, shall be considered final and binding, and must be adhered to by all concerned.

(2) Whoever throws eatables in public place, other than those designated by the Municipal Corporation and thereby enticing Community dogs to assemble at such place for taking eatables which result in causing danger to human life or to be likely to cause injury or annoyance to the public or to the people in general or to cause hindrance in smooth running of vehicular traffic, shall be deemed to be guilty of offence and shall be liable to be proceeded against and punished accordingly as per the relevant provisions of the law as applicable.

19. Responsibility of care giver/occasional feeder:

- (1) It is responsibility of the caregivers/ occasional feeders to ensure that feeding of community dogs and owner less dogs occurs at place designated by the Municipal Corporation and to ensure cleanliness i.e. to avoid any littering during feeding of dogs.
- (2) Whoever throws eatables in public place, other than those designated by the Municipal Corporation, thereby enticing Community dogs causing danger to human life likely injury annoyance to the public and or hindrance in smooth vehicular traffic, shall be deemed to be guilty of offence. They will be liable to be proceeded against and punished accordingly as per the relevant provisions of the law as applicable.

20. Provision for Banning Aggressive/Dangerous Dog(s): For the safety of Public/Society or other living beings the certain breeds of dogs considered as Aggressive/Potentially Aggressive/Dangerous are hereby banned within the jurisdiction of Municipal Corporation Chandigarh as mentioned below:-

| Sr.No. | Dog(s) Breeds |

| 1. | American Bull Dog |
| 2. | American Pitbull/Pitbull Terrier |
| 3. | Bull Terrier/Pakistani Bull Terrier |
| 4. | Cane Corso |

| 7. | Any Cross of above mentioned breeds. |

*****The Commissioner Municipal Corporation Chandigarh reserves the right to modify the list from time to time.***

- a) Above banned dog breeds shall not be registered after due notification of these bye-laws. However, a buffer period of 45 days shall be allowed for existing owners to register their dogs. After this period, any Owner, Pet breeder, Pet Shopkeeper/owner found breeding, keeping, or harboring these banned breeds will be subject to penalties as per the bye-laws, including immediate seizure of the dog(s) by authorized authorities.
- b) This clause shall not be applicable for the dog owners who already have any of these dogs duly registered with Municipal Corporation before due notification of these bye-laws. However, such dog owners need to ensure their dog(s) are muzzled at all times during walking and leashed with equipment strong enough to keep the dog(s) under control to avoid any accident. It is advised to get such dog(s) trained through Dog trainers registered with Municipal Corporation Chandigarh for docile/controlled behavior to avoid any unwanted incident.
- c) Any Owner/Pet Shopkeeper/Pet Breeder, Keeping/Breeding/Harboring any dog(s) of above banned breeds by their actual or other name shall be liable to be punished as per these bye-laws and the dog(s) shall be impounded by the Registration Authority or officials authorized by Registration Authority.

21. Power to Inspect Premises: The Registration Authority, including a Veterinarian, Health Supervisor, Chief Sanitary Inspector, Sanitary Inspector or any other officer of the Municipal Corporation, Chandigarh authorized by the Registration Authority, may inspect the premises of the owner of any dog(s). This shall allow the authorized person to enter and inspect his/her

premises at all reasonable times. This officer/official shall also have authority to search the places where dog(s) are kept without registration and to seize them.

22. Power to impound: The Municipal Corporation shall have the authority to impound any pet dog found unattended at any residence causing nuisance through excessive barking, howling or left fastened unsupervised for extended periods, as well as any dog(s) wandering in public places without supervision or control. The penalty shall be imposed upon the owner of the dog as per **Schedule-VIII**. Any pet dog(s) found straying at large shall be liable to be impound and kept at a place set apart for this purpose. The dog(s) shall be kept in the ABC Centre for a maximum of 10 days. During this period, the owner may claim the dog(s) by paying a fine and maintenance fee. If the owner does not claim the dog(s) within the stipulated time, the registration shall be canceled and the dog(s) shall be sterilized and put up for adoption through registered Volunteers/NGO's (**Schedule-VII**). In case the Pet dog(s) is lost, immediate information must be provided to the Dog Control Cell of Municipal Corporation Chandigarh. In the event of impounding of a registered dog(s), the Municipal Corporation, Chandigarh shall conduct an inquiry into the capability of the owner to ensure proper care, welfare, and supervision of the dog. The owner shall be awarded an opportunity of being heard. If, upon such inquiry, the owner is found to be incapable or negligent in providing necessary care, further proceedings, including but not limited to permanent seizure, cancellation of registration, or other penal action, may be initiated in accordance with the provisions of these bye-laws or other relevant laws/Rules.

23. Penalty:

- a) An owner violating these bye-laws shall be liable to be punished by the Registration Authority with a fine, ranging from Rs. 20/- to Rs. 13,400/- (Penalty as per SWM Rules mandated from time to time) as stipulated in the **Schedule-VIII**. Penalties for multiple violations shall be summed up and for continuing violations, an additional fine may extend to Rs. 20/-per day. If the dog(s) is seized/detained, the owner must pay maintenance charges @ Rs. 250/- per day to claim the dog(s). However, if the breach continues beyond 10 days or the dog(s) is not claimed within 10 days, the registration shall be canceled by the Registration Authority and the seized dog(s) shall be put up for Adoption through registered Volunteers/NGO (**Schedule-VII**).
- b) If an owner of dog(s), Volunteers, Dog Lovers, NGO's, Pet Breeders, Pet Shop Keepers, Dog Hostels/Crèches, Dog Trainers & Dog Groomers whosoever violates any of the conditions of these bye-laws at least four times in a calendar year, shall be liable to pay penalty as stipulated in the **Schedule-VIII**.
- c) If a pet dog(s) causes harm to someone or damages someone's property, the pet owner may face legal action under the relevant provisions of the law as applicable.
- d) If any dog bite is caused by the pet dogs, the owner/Dog Hostel owner/Pet breeder/Pet Shop Keeper shall be liable to pay the compensation to the victim. The liability to pay compensation is without prejudice to any other action which may be taken under the relevant provisions of the law as applicable.
- e) Volunteers, Dog Lovers, NGOs, Pet Breeders, Pet Shop Keepers, Dog Hostels/Crèches, Dog Trainers & Dog Groomers, who violate these bye-laws shall be liable to pay penalties as stipulated in **Schedule-VIII**.

24. Cancellation of Registration and Adoption: Any dog(s) unclaimed by the owner after impounding due to any violation of the "*The Municipal Corporation Chandigarh Pet and Community Dogs Bye-laws, 2025*", by the Municipal Corporation Chandigarh within the stipulated time period i.e. 10 days, shall have its registration canceled if registered and it will

become the property of the Municipal Corporation Chandigarh and the said authority will sterilize the dog(s) and put them up for adoption through Volunteers/Dog Lovers/NGOs duly registered with AWBI/AWOS and/or the Municipal Corporation Chandigarh by submitting the details as per **Schedule-VII**.

25. Appeal against cancellation of registration: Any owner aggrieved by the cancellation order issued by the Registration Authority may file an appeal before the appellate authority within a period of 30 days from the date of the issuance of the cancellation order. The decision of the Commissioner, Municipal Corporation Chandigarh shall be final and binding.

26. Rendering assistance to Registration Authority: The registered volunteers/dog lovers/NGO's/Pet Breeders/pet shopkeepers/dog groomers/dog trainers shall render their assistance to the registration authority under the Animal Birth Control Programme for sterilization, vaccination and de-worming of community dogs as and when required.

27. Final and Binding Authority: The Commissioner of the Municipal Corporation Chandigarh is the final and binding authority to resolve any issues that may arise either of interpretation or of any other kind, which are not explicitly addressed by these bye-laws, including any need to amend these bye-laws in the future.

28. Compensation: In case of any injury caused by any community dog, the compensation shall be decided by the "Chandigarh Stray Animal incident/accident Compensation Committee" constituted by the Chandigarh Administration.

29. Saving: Notwithstanding anything to the contrary contained in this bye-law, any action taken or proceedings initiated under The Chandigarh Registration of Pet Dogs Bye-laws, 2010, shall continue to be valid and enforceable as if they had been taken or initiated under this bye- law.

30. Repeal: The bye-laws issued vide notification No. 6/1/373-FII(8)-2009/4543 dated 07.06.2010 named The Chandigarh Registration of Pet Dogs Bye-laws, 2010, and its subsequent amendments are hereby repealed.



The registration authority shall levy and collect penalty charges from violators. If a violator fails to pay the penalty within 10 days at the office of the Medical Officer of Health, Municipal Corporation Chandigarh (MCC), the MCC shall follow the following recovery procedure:

- The MCC shall add the outstanding amount to the violator's water bill.
- If the violator does not have a water bill, the MCC shall add the outstanding amount to the violator's property tax.
- If the violator does not have property tax, the MCC shall recover the outstanding amount as an arrear of land revenue under the Punjab Revenue Act, as applicable to the Union Territory of Chandigarh.

Any violation under these bye-laws may be compounded either before or after the institution of the challan, by the Medical Officer of Health of Municipal Corporation Chandigarh, subject to payment of the compounded amount by the person.
